***ATTENTION: Out-of-State Applicants**

If your training consisted of the same or more hours than the Virginia requirement, you must submit documentation of your training (see [Training & Experience Verification Form](#)).

If your hours were less than Virginia’s requirement, then you must submit proof of 6 months’ work experience along with your training documentation (see [Training & Experience Verification Form](#)).

If your barber training and scope of practice included chemical texture services, please contact the Board directly to determine whether you qualify for the master barber license.

If your training was obtained outside of the United States or its Territories, you must submit a translated transcript from an accredited translation service detailing your training.
